NEWS FROM THE BOARD AUGUST 2021

1 City Point

The Board has asked Andy Batty, owner of 27CP, to assist, with the next steps. He is Director of Financial Services for PWC. He has said that as a leaseholder, who is both independent personally and professionally of the issues surrounding 1CP, not involved with any "side" in the dispute and not a member of the Board, he would be prepared to attend meetings with retained surveyors and lawyers. He would participate in discussions, review lawyers' suggestions and report to the *leaseholders* his recommendations.

The initial surveyors' report was made available on request following our last Board meeting. If you wish for a copy, contact Kizzy at FHP.

The leaseholders of No 1 have been asked to supply the certification requested by the surveyor. To date they have not responded. The surveyor will be asked to clarify certain matters in his report and finalise it with the information to hand. The report raises questions of possible breach of the lease and so legal advice will then be sought.

Martin Gotheridge as Chairman of the Board, Kizzy Brooks for FHP, Andy Batty, as above, for the leaseholders and the surveyor, as necessary, will deal with and meet our lawyers.

FHP and FHP Living

The observant among you may have noted the change in email addresses and corporate style of our Managing Agents. FHP Living is a completely independent company from FHP (albeit owned by the same two individuals) and your Board has not received any formal notification of the changes. We have requested that Luke Pritchett, a Director of FHP Living, and the person to whom Kizzy Brooks now reports, attends our next Board meeting to explain what is going on and what it means for the management of our properties.

This change made us realise that FHP had been our managing agents for seven years. The Board considers that this is a good opportunity to survey the options available to us for block management. Over the next two months we shall be talking informally with other management companies to gain an updated view.

Garden Report July 2021

All residents received notification of tree works this month so a timely moment to focus on trees.

3 Trees were felled and overgrown shrubs/ivy on the Lenton Road boundary wall reduced.

Tree 1 - a deceased self-set Sycamore on the Lenton Road boundary West Wing RSH.

Tree 2 - a deceased Lilac - West Wing RSH boundary facing Valley House.

Tree 3 a Sycamore situated behind the Lilac abutting the high stone wall facing Valley House. Advice was taken from an arborist, our own Health & Safety Representative and Nottingham City Council.

Tree 1 was borderline on a safety level for the arborist to safely remove - we were only just in time.

Tree 3 has been consistently flagged over the years as dangerous, expert advice from 3 sources recommended felling.

Karin met with Nottingham City Council on site to assess the trees and permission was duly given.

a 'time expired' application form was resubmitted

The Park Estate Office was contacted, and they kindly waived their 'Pavement Charges' on this occasion.

Karin assisted access and liaised with the arborist crew on the day of works.

The Board is happy to report that more trees have been planted these past years than removed

The Board are most grateful to Karin and Ivan for the work they do in conjunction with the Gardening contractors to keep our Community Gardens in such wonderful condition, so admired by us all.

Planning and Licencing

We know that our focus has been the application of the Licence for the Castle now that they are opening again

It is important to realise that the Castle already holds a Full licence and that there are 5 Public houses Locally that have this "Full on Licence" therefore it is not a "new" detriment of our peace and quiet.

However, a number of Residents have expressed their objections to the Application and have made representations which were put forward (brilliantly) by Shilpa Shar at the Licencing hearing of 20th June (B) which is available for all to watch on the Nottingham City Councils You Tube Channel. She also speaks to this on the WhatsApp group comms app.

Because of Shilpa's efforts, and because the Environmental Health (EV) and Nottinghamshire Police asked for and agreed with the Trust a number of Conditions, the Licence was Granted with these conditions in place which make any future events more "Resident disturbance aware"

City Point Painting and Renovation Programme

At the Board meeting reports were submitted by the Maintenance Committee regarding the External Painting of City Point, the current progress and method of work was not deemed satisfactory by either the Board or the Representative of FHP.

A meeting was called at which two directors serving on the maintenance committee and our FHP representative Kizzy Brooks would meet with Whittles to express our dissatisfaction, to insist on a scheme of works to be put in place immediately, and to re-iterate that we insist on high standards and timely completion of the tasks – Failure to comply will lead to a termination of the Contract forthwith.

There are further issues raised by a recent survey of the City Point Roof which will need to be addressed at the next Maintenance Committee meeting and passed to the Board for authorisation of obtaining quotes for the work to be undertaken and a costing implication formulated by the Finance Committee.

Further discussion is underway regarding the overdue Painting of the C.P. car park which was reported on in the service charge budget document distributed to all CP leaseholders, this will be recounted further after the September Board Meeting.
